

TERMS AND CONDITIONS FOR THE 'RECOMMEND US' MARKETING PROMOTION

The purpose of this document is to comprehensively and clearly define the terms and conditions of the 'RECOMMEND US' marketing promotion (hereinafter referred to as the 'Promotion').

These Rules constitute the exclusive document governing the terms and conditions of the Promotion (referred to as the 'Rules'). The terms and conditions of the Promotion are subject to amendments outlined in the Rules below.

1. Organizer and promoter

The organizer of the Promotion is RONDA INVEST a.s., with its registered office at Výtvarná 1023/4, Ruzyně, 161 00 Prague 6, ID No.: 06370772, registered in the Commercial Register maintained by the Municipal Court in Prague, Section B, Insert 22788. In this document, 'RONDA INVEST' and 'Organizer' are used interchangeably.

2. Participation

Participation establishes a contractual relationship between the Organizer and the client (Participant), granting the client (Participant) the right to receive a portion of the principal and yield income from loan receivables. The client (Participant) makes this investment through the assignment of the yield at their own discretion. It's important to note that Participation is not considered an investment instrument, cannot be transferred or traded between clients, and is not a derivative instrument. Additionally, a Participation is not classified as a security.

3. Duration of the Promotion

The Promotion runs from 15.11.2023 to 31.12.2024.

4. Participants of the Promotion

The Promotion is accessible to both existing and new participants. An existing participant refers to all natural persons and legal entities with at least one active participation product with Ronda Invest, hereinafter referred to as 'Existing Participant.' On the other hand, a new participant is any potential participant who is not already an existing participant at the time of joining the promotion, hereinafter referred to as 'New Participant.'

5. Involvement in the Action

An Existing or New Participant becomes part of the Promotion by referring another New Participant, who, during the Promotion period, establishes one or more Participations. The referring Participant is also known as 'Referring Participant' and the referred Participant is also known as 'Referred Participant.' The moment of establishing a Participation is considered the moment when the invested amount is transferred in favor of the Organizer from the New Participant's account with PAYMONT UAB, company number: 305673740, hereinafter referred to as the 'Establishment of a Participation Product.'

6. Place and time of Establishment of a Participation Product

. The Participation product can be established by the Referred Participant online through the RONDA

INVEST investment application on the website <https://online.rondainvest.cz/register> or at the Organizer's Trading Point. It can also be established anywhere outside the Organizer's Trading Point with the presence of the Organizer's representative, provided that the registration is done using the reference link of the Referred Participant. The creation of the Participation product must occur within the Promotion Period.

7. Remuneration and conditions for granting it

In this Promotion, the remuneration is a cash bonus set as a percentage of the amount invested by the Referred Participant in the first 30 from the start of registration. The bonus, specified in amount, will be awarded to both the Referring Participant and the Referred Participant who meet the conditions outlined in this section of the Rules. This constitutes the 'Referring Participant Remuneration' and the 'Referred Participant Remuneration,' respectively:

- During the Promotion Period, the Referring Participant must be an active client of RONDA INVEST with an invested amount of at least CZK 1,000.
- Within the Promotion Period, the Referred Participant must activate a Participation product with an aggregate invested amount of at least CZK 10,000 or EUR 400 in 30 days from the start of registration through the Referred Participant's referral link. If the Referred Participant establishes a Participation product in both currencies, i.e., CZK and EUR, the aggregate amount invested, using the conversion rate of 25 CZK/EUR, must be at least CZK 10,000.
- The Referred Participant is required to click on the referral link from the Referring Participant before initiating the registration process. During the registration of the Referred Participant, this code will be automatically entered in the Intermediary Code field in step 6 of the registration form.

The Referring Participant must be an Existing Participant by the time the Referral Remuneration is paid to the Referred Participant they have referred. Failure to meet this condition will result in the cessation of the Referring Participant's entitlement to the Remuneration payment.

The Basic Remuneration for the Referring Participant and the Remuneration for the Referred Participant are both fixed at 0.5% of the amount invested by the Referred Participant in 30 days from the start of registration through the Referring Participant's referral link. The total investment during this period must surpass at least CZK 10,000. It's crucial to highlight that the Referred Participant's Remuneration is capped at a maximum total payout of CZK 1,000.

The Remuneration for the Referring Participant is delineated across various bands, as outlined in the table below:

If the Referred Participant initiates the establishment of a First Participation Product with an amount less than 10,000 CZK, the Referring Participant's Remuneration must be increased within 30 days from the start of the registration. The aggregate amount of funds invested in all products should then reach at least 10,000 CZK or 400 EUR.

At its sole discretion, the Organizer may also choose to award a Remuneration to Referring Participants who, due to reasons not inconsistent with good morals, fail to meet the condition of establishing a Participation product during the Promotion Period.

8. Method and dates of delivery of the Remuneration

The Remuneration will be disbursed to Promotion Participants in cash to the account held with PAYMONT UAB., company number: 305673740, along with the yield of the Participation following the fulfillment of the conditions for the Remuneration. The currency of the Remuneration will be determined based on the currency of the Participations in which the Participant invests. If the Participant invests in both CZK and EUR Participations, the bonus will be paid in the currency of the Participation in which the conditions for the Remuneration payment have been met. In case of any dispute regarding the currency, method, or date of Bonus delivery, the Organizer's decision shall be final.

9. Informing the Participant about the processing of personal data

For the purpose of participating in the Promotion, evaluating the Promotion, and informing Participants about the award and payment of the Remuneration, the Organizer will process the personal data of the Participants. Information on the processing of personal data by the Organizer is included in the contractual documentation concluded with each client.

10. Final provisions

The Participant is not legally entitled to the Remuneration through participation in the Promotion, and the Remuneration cannot be enforced in court. Additionally, the Remuneration cannot be paid in cash, exchanged for non-cash benefits, or swapped for rewards or bonuses from other promotions. No statement or document from the Organizer constitutes a public promise or proposal to enter into a contract under the Civil Code.

As the recipient of the Remuneration, the Promotion Participant is fully responsible for complying with any tax obligations arising under the law in connection with the receipt of the Remuneration.

The Organizer reserves the right to change the terms and conditions of this Promotion at any time, including during the course of the Promotion. This includes the ability to alter the duration of the Promotion, such as extending, suspending, or terminating it early. The Organizer will inform Promotion Participants of any changes on its website. Any complaints or objections will be finally decided by the Organizer.

If, during the Promotion, a Participant is found to have acted in breach of the Rules, good manners, rules of fair dealing, or the purpose of the Promotion, or is found to have acted in any other speculative

manner that may jeopardize or damage the goodwill of the Organizer, the Organizer reserves the right to consider each case and decide on any sanctions. This may result in the loss of any Remuneration earned or the exclusion of the Participant from the Promotion without compensation. Actions under the previous sentence may also be considered a breach of the Participation Agreement.
